Simples[™] - Terms of Use (Terms)

The Compare The Market™ Simples™ Application (Simples™ or the App) is able to be accessed and used on your Apple iPhone or Android mobile telephone or tablet (Device) and is owned and operated by CTM. "Compare the Market" is an Australian business name and trade mark of CTM. The meaning given to certain words used in these Terms are contained in the "Definitions" section below or throughout these Terms and they apply in all sections of these Terms.

Fuel prices supplied by The Pricing Project Services Pty Ltd (**TPP**). In South Australia, fuel prices are based on, or contain data provided by the State of South Australia (office of Consumer and Business Services 2021 – 2023. Copyright of the State of South Australia).

Acceptance of Terms

By using Simples, you agree to the terms of this document and the <u>CTM Privacy Policy</u>. Please read them carefully before proceeding. If You do not agree to these Terms or the <u>CTM Privacy Policy</u>, You must not use or access Simples.

These Terms are intended to be for the benefit of each of CTM, its Related Bodies Corporate and their respective Personnel.

The Simples App

Simples provides an information service to allow You to obtain data which includes fuel prices at Service Stations offering various types of petroleum products to You and other members of the public.

The data provided to You in Simples will include fuel prices that are dated and time stamped at the location of the Service Station (**Fuel Prices**); the Service Stations offering the lowest Fuel Prices in the locations nearest to you at the time that you access the App; the Fuel Prices along the path of travel to the Service Station displaying the lowest Fuel Price; the Service Station's features such as the name, address, city, State, post code; the Service Station Brand (**Fuel Brands**) and amenities; the grades of petroleum products available at the Service Station including regular, midgrade, premium, diesel and any other fuel or grades of fuel available in Australia (**Fuel Grades**) plus Fuel Price trends, analysis data of Fuel Prices and Fuel Grades for the previous 3 months in the territory in which You are using Simples to obtain the data (**App Data**).

The App Data quoted and compared in Simples does not provide information on all of the Service Stations, Fuel Brands, Fuel Prices, Fuel Grades or other Content available in the market or in the territory in which You are searching while using Simples and CTM only compares that App Data for Participating Service Stations. At times, the App Data may not be available or up to date, even for the Participating Service Stations.

In some regional areas, regular price comparisons for individual Participating Service Stations may not be available. In those cases, an average Fuel Price for the previous day for a particular area may be provided and in some cases, it is only available for the previous week.

As the App Data is owned, operated and controlled by third parties and not CTM, CTM takes no responsibility for the App Data or its Content.

Jurisdiction

The information on Simples is provided for Australian residents only. The law applicable to these Terms is the law in force in the State of Queensland, Australia and use of the App and the resolution of any disputes arising from access to and use of the App will be decided in accordance with that law. You and CTM submit to the exclusive jurisdiction of the courts and tribunals of the State of Queensland.

Definitions

Authorised End Users means individuals or entities that subscribe to or have access to the App for their own immediate use or consumption, including for personal, family, household or internal business purposes and not for resale to any third person.

Content means the content, text, data, information, images, pages, materials, tools, hypertext links and results contained on the App including the App Data.

CTM Push Notifications means any notifications or information that appears on Your Device when You are using the App which has been activated by or on behalf of CTM for You providing news, information and offers about CTM and the App.



CTM Websites means collectively and individually, the Compare the Market Website, www.captaincompare.com.au, and the Compare the Meerkat Website, www.captaincompare.com.au, whichever is applicable.

Loss means any damage, loss, cost, expense or liability however it arises and whether it is direct or indirect, present or future, fixed or unascertained, actual or contingent and includes all legal costs and expenses.

Participating Service Stations means those individual Service Stations which have chosen to participate on or whose prices are collected for comparison in Simples.

Personnel means the directors, officers, employees, agents and contractors of a person.

Related Bodies Corporate has the same meaning as in the Corporations Act 2001 (Cth).

Service Stations means the service stations situated in Australia that are retail outlets for the sale of petroleum products in Australia.

Terms means these Simples terms of use along with the CTM Privacy Policy and any other terms and conditions set out in the App.

You or Your means the Authorised End User of Simples.
